### Safe Transportation Procedure

#### Elizabeth North Preschool Safe Transportation Procedure

This procedure applies to Occasional Care and Preschool.

#### National Quality Standards

#### Education and Care Services National Regulation

#### Education and Early Childhood Services (Registration and Standards) Act 2011, Schedule 1 Education and Care Services National Law (South Australia)

#### Procedure Statement

Staff at Elizabeth North Preschool aim to protect the health, safety and wellbeing of each child at all times in relation to safe transport of children. This procedure aims to minimise risks of accidents and injuries on excursions, respond effectively to emergencies and promote awareness in Elizabeth North Occasional Care and Preschool children and their families/carers of road safety and play safety.

#### Rationale

"Transportation may present additional risks to children depending on how it occurs and how transition between a vehicle and an education and care service premises or other location is managed. These risks apply equally to single trips or during periods of regular transportation. Risk assessments must identify and assess risks that the transportation of a child may pose to the safety, health or wellbeing of the child, and specify how the identified risks will be managed and minimised." ([ACECQA, 2020](#)).

#### Implementation

Our staff will:

### Preparation

- Select buses with seatbelts when booking private transport
- Select buses that accommodate the number of children and adults it is licensed to carry
- Ensure that no child is transported by the service without authorisation from their family
- Ensure appropriate risk assessments in relation to transportation are completed and actions are undertaken, inclusive of determination of appropriate adult to child ratios. Inclusion will feature within the risk assessment to ensure all children can participate. Student Support Services will support planning where required
- Check at least staff member with current required first aid certification is in attendance
- Use child friendly language to discuss safety risks and minimisation with children in advance e.g., sitting on the bus, listening to staff
- Arrangements for telephone contact while on the excursion will be made and the School Principal or delegate will be notified of the excursion if there will be no one at Elizabeth North Preschool.
- The esky used for evacuations, including first aid kit, drinking water, medical plans, family contact information will be checked and taken on all excursions
- Ensure this procedure is included in induction of new and relief staff

### While transporting

- Ensure all supervision requirements are met during transportation (Leader Band 3)
- Ensure first aid requirements are met during transportation (Leader Band 3)
- Undertake regular attendance checks to account for all children (designated teachers)
  - Roll call on the bus before departing site
  - Roll call off the bus when arriving at destination (inclusive of thorough physical checks to confirm all children have exited – on seats, under seats)
  - Roll call on the bus before departing destination
  - Roll call off the bus when arriving at site (inclusive of thorough physical checks to confirm all children have exited – on seats, under seats)
- Teachers will ensure that all required equipment and items are taken on the transportation, including but not limited to:
  - First aid kit
  - Children's medication
  - Emergency contact list
  - Mobile phone

### In the event of an accident

- Remove children from the dangerous situation
- Contact emergency services
- Administer First Aid (first aid qualified staff member) – this staff member will allocate children in their care to other adults
- Inform the site and children's families as soon as practical, especially if in an urgent situation
- Complete relevant reports as soon as practical (e.g., Accident Report, Injury Report, IRMS)

### In the event a child is not accounted for

- Conduct the roll immediately
- Search the immediate area
- Call police
- Notify site and family

- Complete IRMS as soon as practical

If a child's guardian is not contactable upon disembarking the family will be called by the Leader Band 3. Failing this, emergency contacts will be called. Preschool staff will remain with the child until an authorized adult collect.
